NOTIFICATION



Syndicate, in its 81st meeting, held on 14th June 2024, on the recommendations of Academic Council, and in exercise of its powers under section 27.(1) and 31.(2)(i) of UHS Ordinance 2002, approved 'Policy for Imposing Fine/Other Disciplinary Action against Students at Affiliated Colleges/On-campus, UHS', reproduced below:

1. The constituent and affiliated institutions of UHS are restrained from imposing fine upon their students for absence from the classes. Imposition of fine or any disciplinary action should be replaced with counselling and parent-teacher meetings.
2. The colleges may with approval of their Academic Councils, regulate conduct and discipline of their students, under the provisions of UHS 'Regulations for Conduct & Discipline of Students', available at its website. The colleges may constitute Disciplinary Committees comprising senior faculty members rather than putting reliance upon their administrative staff for maintenance of discipline. Code of conduct prescribed by the colleges for their students shall be submitted to the university for approval and shall also be incorporated in their prospectus, as well as on their websites. The university shall be kept informed of any disciplinary action taken by a college against its students, especially the cases of suspension of academic activities of a student, which shall require prior approval of UHS.
3. The colleges may refer the matters pertaining to conduct and discipline of their students, not covered in any prescribed regulations, to UHS for Consideration of its Discipline Committee constituted under the UHS 'Regulations for Conduct & Discipline of Students'.
4. The colleges shall conduct parent-teacher meetings for all cases of failure/poor performance in a block in the modular integrated scheme, within fifteen days of completion of each block, and to notify the same to the university.

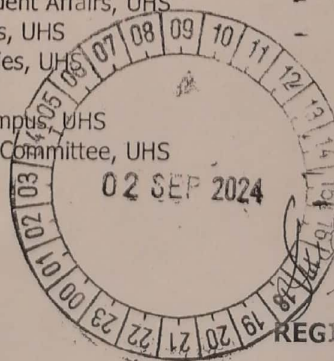
